This Form of Proxy (this “proxy”) is solicited by and on behalf of Management (“Management”) of MCAN Mortgage Corporation (d/b/a MCAN Financial Group) (the “Corporation”).

### Notes to proxy

- If you want to attend and vote at the meeting, please write your name in the blank space provided for that purpose on the reverse of this form. Every shareholder has the right to appoint some other person or company of their choice, who need not be the Corporation or a shareholder of the Corporation, to attend and act on their behalf at the meeting. If you wish to appoint a person or company other than the persons whose names are printed herein, please insert the name of your chosen proxyholder in the space provided on the reverse and return your proxy by mail or vote by internet at [www.investorvote.com](http://www.investorvote.com). In addition, YOU MUST go to <http://www.computershare.com/MCAN> by 5:00 p.m., Toronto time, on May 3, 2024, and provide Computershare with the required information for the chosen proxyholder so that Computershare may provide the proxyholder with an invite code via email. This invite code will allow your proxyholder to log in to and vote at the meeting. Without an invite code, your proxyholder will only be able to log in to the meeting as a guest and will not be able to vote.
- If the securities are registered in the name of more than one owner (for example, joint ownership, trustees, executors, etc.), then all those registered holders should sign this proxy. If you are voting on behalf of a corporation or another individual, you may be required to provide documentation evidencing your power to sign this proxy with signing capacity stated.
- This proxy should be signed in the exact manner as the name appears on the proxy.
- If this proxy is not dated, it will be deemed to bear the date on which it is mailed by Management to the shareholder.
- The securities represented by this proxy will be voted as directed by the shareholder. In the absence of such directions, this proxy will be voted FOR the matters listed in items 1, 2, and 3 and with respect to item 1, the votes will be distributed equally among the nominated directors.
- The securities represented by this proxy will be voted or withheld from voting, in accordance with the instructions of the shareholder, on any ballot that may be called for and, if the shareholder has specified a choice with respect to any matter to be acted on, the securities will be voted accordingly.
- This proxy confers discretionary authority in respect of amendments to matters identified in the Notice of Meeting or other matters that may properly come before the meeting or any adjournment or postponement thereof.
