



Dividend Payments – T5 Reporting

MCAN Mortgage Corporation (“MCAN”) d/b/a MCAN Financial Group is a Mortgage Investment Corporation (“MIC”) under Section 130.1 of the Income Tax Act (Canada). As a MIC, MCAN is entitled to deduct the dividends it pays to shareholders from its taxable income. Regular dividends are taxed as interest income to MCAN’s shareholders.

In order to take advantage of the tax benefits provided by the MIC status as a flow-through vehicle, MCAN’s policy is to pay out all of its non-consolidated taxable income to shareholders through dividends. MCAN currently pays a quarterly dividend payable on or about each of March 30, June 30, September 30 and January 2. Additional dividends may be declared by MCAN from time to time.

For tax reporting of MCAN dividends, T5 slips are issued by the brokerage firm through which you purchased the MCAN shares. If you have not received your T5 slip, please contact your broker directly as MCAN is not involved in sending these out.

For reporting on T5 slips, interest dividends from a MIC are recorded in Box 13. In addition, a MIC may from time to time pay dividends in respect of capital gains that it has earned. These are taxed as capital gains from the disposition of capital property. For reporting on T5 slips, capital gains dividends from a MIC are recorded in Box 18.

Please note: For non-resident shareholders, dividend income may be subject to withholding tax. For further information, please discuss with your investment advisor.
